

# News Notes

**Accessible Archives**, a leading publisher of electronic full-text searchable historical databases, has announced the availability of Part III of *The Liberator* and Part XII of African-American Newspapers: The 19th Century, two of its premier collections.

William Lloyd Garrison published the first issue of *The Liberator* on January 1, 1831, with the motto: "Our country is the world—our countrymen are mankind." A journalistic crusader advocating the immediate emancipation of all slaves, Garrison gained a national reputation for being one of the most radical of American abolitionists. The most influential newspaper in the antebellum antislavery crusade, *The Liberator* was published through December 1865.

The Accessible Archives full text online version of *The Liberator* is produced in seven parts. Parts I through III, covering January 1831 to December 1845, are available now, with the remaining four sections expected to be issued on an annual basis.

With the addition of Part XII of African-American Newspapers: The 19th Century at the end of 2007, the 12 parts of this collection will provide more than 120,000 articles. Newspapers included in this database are being made available in chronological order, with the addition of some 10,000 articles each year. The newspapers currently in the database are as follows: *Freedom's Journal*, 1827–1830 (New York, NY); *The Colored American*, 1837–1841 (New York, NY); *The North Star*, 1847–1851 (Rochester, NY); *Frederick Douglass Paper*, 1851–1859 (Rochester, NY, completed through 1855); *The National Era*, 1847–1860 (Washington, DC); *Provincial Freeman*, 1854–1857 (Toronto, Canada); and *The Christian Recorder*, 1861–1902 (Philadelphia, PA, through 1902; 1892 is unavailable).

Founded in 1990, Accessible Archives utilizes computer technology to provide vast quantities of archived historical information previously available only in microformat. Diverse primary source materials reflecting broad views across American history and culture have been assembled into comprehensive databases. Developed by dedicated instructors and students of Americana, these databases allow access to the rich store of materials from leading books and periodicals then current. Three winning books and two honorable mentions have been selected to receive the inaugural **Arab American National Museum Book Award**. The winners, all published in 2006, are: Adult Nonfiction—*The Iron Cage: The Story of the Palestinian Struggle for Statehood* by Rashid Khalidi (Beacon Press); Adult Fiction—*In the Country of Men* by Hisham Matar (The Dial Press); Children or Young Adult—*One Green Apple* by Eve Bunting, illustrated by Ted Lewin (Clarion Books). The two honorable mentions were both in the adult nonfiction category—*The Arab Americans* by Randa A. Kayyali (Greenwood Press) and *"Evil" Arabs in American Popular Film: Orientalist Fear* by Tim Jon Semmerling (University

of Texas Press). The honored books and their authors received their awards at a gala at the Arab American National Museum (AANM) in Dearborn, Michigan, in September 2007.

The Arab American National Museum Book Award encourages the publication and excellence of books that preserve and advance the understanding, knowledge, and resources of the Arab-American community by celebrating the thoughts and lives of Arab Americans. The purpose of the award is to inspire authors, educate readers, and foster a respect and understanding of Arab-American culture. The winning titles were chosen by a committee of readers comprised of respected authors, university professors and artists, and from the AANM, Library & Resource Center Manager Angelita Espino and Manager of Education and Public Programming Celine Taminian.

The Arab American National Museum documents, preserves, celebrates, and educates the public on the history, life, culture, and contributions of Arab Americans. The **Barahona Center for the Study of Books in Spanish for Children and Adolescents** at California State University San Marcos is pleased to announce three workshops for summer 2008.

From June 9 to 11, "Current Issues: Books in Spanish for Young Readers" will be offered. This workshop is an introduction to and analysis of current practices and problems in selecting and using books in Spanish for children and adolescents. Sample topics and activities include a discussion of reader appeal and literary quality, the Spanish-language publishing world, and language issues. The three-day workshop is conducted in English.

"Books and Reading Strategies for English-Language Learners in Grades K–8" will be offered June 23–25. This workshop will focus on the language and culture of English-language learners through the selection of appropriate multicultural literature and will use quality multicultural literature to teach reading strategies and foster literacy development. Topics and activities include: Thematic units, Preview/Review, DRTA (Directed Reading Thinking Activity), QAR (Question-Answer Relationships), Reciprocal Questioning, Reader's Theater, Choral Reading, Visualization, and Responding through the Arts. Methods for accelerating vocabulary development and motivating readers also will be demonstrated. This workshop is also conducted in English.

The final workshop, to be held July 14–16 and taught in Spanish, is "Books in Spanish for Children and Adolescents/Los libros en español para niños y adolescentes." This workshop introduces quality fiction, nonfiction, and reference books in Spanish for children and adolescents, including different genres, subjects, and countries of publication. Spanish-speaking ability is not required

to attend.

Workshop sessions will be from 9:00 a.m. to 3:00 p.m. Students will be free to use the resources of the Center in the afternoons. The cost for each three-day workshop is \$115. Enrollment is limited; early registration is definitely recommended.

**Cinco Puntos Press** is thrilled to announce that *Crossing Bok Chitto*, written by Tim Tingle and illustrated by Jeanne Rorex Bridges, has been included on the Bluebonnet Master List of the Texas Library Association (TLA) for 2008-09. The Bluebonnet is a library-based literacy program sponsored by the TLA. Each year, a committee of Texas librarians picks 20 of their favorite books for children in grades three to six. The children then vote for their favorites, but to gain franchise, each child has to read five books from the Master List. In 2007, 170,000 children participated in the Bluebonnet voting, making the award program responsible for encouraging Texas children to read at least 850,000 books. In October 2007 **Facing History**, a Boston-based nonprofit organization devoted to education against prejudice, launched a new web site geared to secondary school students and community groups, "Be the Change: Upstanders for Human Rights."

The web site, at [www.facinghistory.org/BeTheChange](http://www.facinghistory.org/BeTheChange), presents the stories of five extraordinary men and women who have made a positive difference in the world. They are Arn Chorn Pond, a musician and survivor of the Cambodian genocide; Vanita Gupta, the Indian-born human rights lawyer advocating for unjustly imprisoned African Americans in rural East Texas; Nigerian woman AIDS activist Yinka Jegede-Ekpe; Martin O'Brien, an advocate for human rights and nonviolence in Northern Ireland; and Dr. Ernest Guevarra, who is working to improve health care among the poor of the Philippines. Created with the help of student interviewers, "Be the Change" looks at the influences, inspirations, and motivations that led the five upstanders to take action on behalf of others. By taking the journey through the web site, students connect with a growing global network of their peers who care about creating a more just world.

On November 6, 2007, Latin & World Music label **iASO Records** celebrated its first releases. *The Bachata Roja* collection and Puerto Plata's *Mujer de Cabaret* (distributed by Ryko USA & Warner Digital) together reveal 60 years of the vibrant acoustic guitar tradition of the Dominican Republic. Repressed under Rafael Trujillo's regime and reviled by elite society, this roots music has never before been heard internationally.

*Bachata Roja* is the first ever compilation of classic Dominican *bachata*. Arising from the urban *bordellos* and the rural *campos*, *bachata* music grew to become wildly popular across all strata of society. From the early 1960s to the late 1980s, the defining sound of *bachata* was that of the Spanish acoustic guitar, whose florid phrasing seduced dancers, chastised faithless lovers, and softly serenaded coy mistresses of the night.

Puerto Plata's debut album *Mujer de Cabaret* is reminiscent of the golden age of Dominican guitar music. A contemporary of the Cuban greats of the 1930s and 1940s, Puerto Plata sings classic *son*, *bolero*, and *merengue* in a style that gives testament to a time gone but not forgotten, of serenades, carousing, and revelry.

Eight new scientific journals from **Marquette Books** that focus on communication processes and effects will be available free of charge to scholars and the public beginning in 2008.

Publisher David Demers said he believes this is the first time a privately owned publishing house has made all of its journals open access. According to the Directory of Open Access Journals ([www.doaj.org](http://www.doaj.org)), almost all open access journals are published by universities or nonprofit organizations, which in turn receive financial support from tax revenues or private donations.

A table of contents for each issue of the quarterly journals and Internet links to the journals' web site ([www.marquettejournals.org](http://www.marquettejournals.org)) will be e-mailed to more than 20,000 scholars, librarians, politicians, and journalists around the world.

To compensate for some of the loss of subscription revenue, Demers said the online portal through which scholars and the public will access the PDF content of MB journals will contain some advertising for MB's scholarly and trade books. The eight journals scheduled for publication in Winter 2008 are *Journal of Media Sociology*, *Journal of Global Mass Communication*, *Russian Journal of Communication*, *Journal of Health & Mass Communication*, *Journal of Media Law & Ethics*, *American Journal of Media Psychology*, *Journal of Communication Studies*, and *International Journal of Media and Foreign Affairs*.

A civic-minded group of Canadian eleventh graders recently journeyed to the Queenstown Get Ahead Project (QGAP) schools

in the Eastern Cape region of South Africa to help younger students learn geography, mapping, and computer skills. Using donated licenses of **Tom Snyder Productions'** Neighborhood MapMachine 2.0 software, students from both school districts learned lessons about mapping, collaboration, and community.

The community service project began earlier this year when the eleventh graders from the Branksome Hall School in Toronto, Ontario, asked Scholastic, the corporate parent of Tom Snyder Productions, to donate licenses of the Neighborhood MapMachine software to outfit the schools in Queenstown. They wanted to use the software to teach the students at the QGAP schools about geography and mapping. The eleventh graders learned about the program from the students in Branksome Hall's fourth grade class who use it as part of their "Finding Our Way" mapping inquiry unit.

For each of the past three years, the Branksome Hall School has organized trips to the QGAP schools. Participants have acted as teachers and mentors, running curriculum programs for students and professional development workshops for teachers. During this year's trip, the group installed Neighborhood MapMachine 2.0 on the schools' computers and helped the QGAP schools learn how to use it.

After winning multiple audience and critic awards at film festivals across the country, after its nomination for the Best Documentary Short Subject Academy Award, and after its acclaimed broadcast on HBO/Cinemax's Reel Life Series, this powerful film has received the top honors from the National Academy of Television Arts & Sciences. The other documentary winner is a Canadian film also about the Rwandan genocide, *Shake Hands with the Devil: The Journey of Roméo Dallaire*. The News and Documentary Emmys were presented in fall 2007 in New York City.

The 1994 Rwandan genocide left the country nearly 70 percent female, handing Rwanda's women an extraordinary burden and an unprecedented opportunity. An inspiring story of loss and redemption, *God Sleeps in Rwanda* captures the spirit of five courageous women as they rebuild their lives, redefining women's roles in Rwandan society and bringing hope to a wounded nation. 🌍
